

ORDINANCE NO. 326

AN ORDINANCE PROVIDING FOR THE VACATION OF SILVER STREET LOCATED BETWEEN LOTS 1, 2 AND 3, BLOCK 2, AND LOTS 6, 7 AND 8, BLOCK 3, ALL IN THE HILLCREST PARK ADDITION TO THE CITY OF BESSEMER, GOGEBIC COUNTY, MICHIGAN, ACCORDING TO THE RECORDED PLAT THEREOF.

WHEREAS; The Bessemer Housing Commission petitioned for the vacation of Silver Street located between Lots 1, 2 and 3, Block 2, and Lots 6, 7 and 8, Block 3, all in the Hillcrest Park Addition to the City of Bessemer, Gogebic County, Michigan, according to the recorded plat thereof.

WHEREAS; The City Council, after due consideration of said petition noted above including a public hearing regarding same on March 10, 1983, and an affirmative vote to vacate also regarding same on April 18, 1983, determined that the health, welfare, comfort and safety of the people of the City of Bessemer will be served by vacating that portion of said Silver Street as described herein.

NOW, THEREFORE, THE CITY OF BESSEMER ORDAINS:

Section 1. The vacation of Silver Street located between Lots 1, 2 and 3, Block 2, and Lots 6, 7 and 8, Block 3, all in the Hillcrest Park Addition to the City of Bessemer, Gogebic County, Michigan, according to the recorded plat thereof, hereby is vacated, and said street so vacated shall vest in the rightful proprietors owning lands adjacent thereto and bordering thereon as shown in the Plat of said Addition.


Section 2. The City Clerk of the City of Bessemer, Michigan is hereby directed within thirty (30) days after the adoption of said ordinance to record a certified copy of this ordinance with the Gogebic County (Michigan) Register of Deeds, and further send a copy of said Ordinance to the State Treasurer of the State of Michigan.


Section 3. All ordinances or parts of ordinances or resolutions in conflict herewith are hereby repealed.

Section 4. This ordinance shall be published pursuant to Section 6.4 of the City Charter, and shall be effective upon recordation with said Register of Deeds pursuant to MCLA 560.256, as amended.
