**ORDINANCE NO. 327**

AN ORDINANCE PROVIDING FOR THE VACATION OF A PORTION OF BEECHER STREET DESCRIBED AS A STRIP OF LAND RUNNING PARALLEL WITH BLOCK FIFTEEN (15) OF HIBBING'S ADDITION, FORTY (40) FEET WIDE AND 280 FEET LONG, BEING A PORTION OF SECTION TEN (10), TOWNSHIP FORTY-SEVEN NORTH (T47N), RANGE FORTY-SIX WEST (R46W), CITY OF BESSEMER, GOGEBIC COUNTY, MICHIGAN.

**WHEREAS;** Ms. Barbara Gust petitioned for the vacation of a portion of Beecher Street described as a strip of land running parallel with Block Fifteen (15) of Hibbing's Addition, forty (40) feet wide and 280 feet long, being a portion of Section Ten (10), Township Forty-seven North (T47N), Range Forty-six West (R46W), City of Bessemer, Gogebic County, Michigan.

**WHEREAS;** The City Council, after due consideration of said petition noted above including a public hearing regarding same on April 17, 2006, determined that the health, welfare, comfort and safety of the people of the City of Bessemer will be served by vacating that portion of said Beecher Street as described herein.

**NOW, THEREFORE, THE CITY OF BESSEMER ORDAINS:**

Section 1. The vacation of a portion of Beecher Street described as a strip of land running parallel with Block Fifteen (15) of Hibbing's Addition, forty (40) feet wide and 280 feet long, being a portion of Section Ten (10), Township Forty-seven North (T47N), Range Forty-six West (R46W), City of Bessemer, Gogebic County, Michigan, hereby is vacated, and said street so vacated shall vest in the rightful proprietors owning lands adjacent thereto and bordering thereon as shown in the plat of said Addition.

Section 2. The City Clerk of the City of Bessemer, Michigan is hereby directed within thirty (30) days after the adoption of said ordinance to record a certified copy of this ordinance with the Gogebic County (Michigan) Register of Deeds, and further send a copy of said Ordinance to the State Treasurer of the State of Michigan.

Section 3. All ordinances or parts of ordinances or resolutions in conflict herewith are hereby repealed.

Section 4. This ordinance shall be published pursuant to Section 6.4 of the City Charter, and shall be effective upon recordation with said Register of Deeds pursuant to MCLA 560.256, as amended.


