

ORDINANCE NO. 366

An ordinance to repeal antiquated ordinances and sections of the City of Bessemer's Code.

Whereas the City of Bessemer is interesting in removing antiquated ordinances, the City hereby ordains that the following ordinances be repealed:

ORDINANCE 272, AN ORDINANCE GRANTING AND RENEWING A FRANCHISE TO BRESNAN COMMUNICATIONS COMPANY, ITS SUCCESSORS AND ASSIGNS TO CONSTRUCT OPERATE AND MAINTAIN A CABLE TELEVISION SYSTEM IN THE STATE OF MICHIGAN, AND SETTING TERMS AND CONDITIONS THEREFORE.


